VOICES OF CHILD HEALTH IN CHICAGO REPORT

[Children with Special Health Care Needs in Chicago](#)

In this report, [Voices of Child Health in Chicago](#) explore the issue of children with special health care needs in Chicago. Specifically, researchers asked parents, "Is your child/Are any of your children limited or prevented in any way in his or her/their ability to do the things most children of the same age can do?" They also asked parents questions about their own health. Highlights of the report include: Seven percent of Chicago parents said they had a child with special health care needs (SHCN); Parents with only boys, only girls, and boys and girls were equally likely to report having a child with SHCN; Parents of children with SHCN were more likely to be in worse health themselves and to have experienced psychological distress.
