Parents, children and families in Chicago and across the world have faced unprecedented challenges during the COVID-19 pandemic. COVID-19 is the illness caused by

a coronavirus called SARS-CoV2, and the COVID-19 outbreak was declared a global pandemic by the World Health Organization on March 19, 2020. In this report, Voices of Child Health in Chicago explore parents' attitudes about the COVID-19 pandemic. Report highlights include the following: More than 3 in 5 Chicago parents were very concerned about COVID-19 affecting their family's health; Non-Latinx Black parents reported the highest levels of concern about COVID-19; and Chicago parents had the most trust in COVID-19 information that came from their child's doctor or their own doctor.
